- 3. Responsibility for Loss or Damage, Insurance Coverage: BAC is responsible for the safekeeping of all Artworks while they are in its custody. The Berea Arts Council is responsible to the extent that our Bailee's coverage provides. (A printed copy of the policy is available upon request.)
- 4. The Artist agrees to give ultimate control over the display or storage of the Artworks to BAC. This means that altering hanging devices if they are not suitable may be altered or denied from the show.
- 5. The Artist gives permission to the Berea Arts Council (BAC) to sell works of art or craft covered by this agreement. BAC will offer the artworks for sale at the retail price specified on the contract or inventory sheet. BAC will receive a 40% commission on all items sold in the BAC galleries.
- 6. Reproduction: The Artist reserves all rights to the reproduction of the Artworks except as noted in writing to the contrary. BAC may arrange to have the Artworks photographed for educational
